JOB SUMMARY

The Mental Health Nurse is a member of the interdisciplinary and interestablishment team whose aim is to support clients experiencing mental health and/or behavioral challenges and assist them to improve their emotional, psychological, social, spiritual and family functioning. The Mental Health Nurse collaborates with the client, the client's interdisciplinary team, family, and health care professionals to develop an Integrated Service Plan. The Mental Health Nurse has the expertise and training which enables them to intervene in numerous clinical situations, and thus may act as a resource person within KMHC.

RESPONSIBILITIES

- Meets and maintains Standards of Professional Nursing Competence
- Formulates a nursing care plan and goals adherent to the accepted standards of nursing care practice
- Provides client care adherent to the accepted Standards of Patient Care
- Participates in the development, implementation and evaluation of a nursing care plan that is based on standards of nursing care practice, scientific knowledge, evidence based interventions, and according to best practices
- Collaborates with the interdisciplinary and interestablishment team to assist clients to develop and achieve goals agreed upon in their Integrated Service Plan
- Responsible to meet continuing education needs required by KMHC and OIIQ
- Participates in Quality Improvement activities recommended for the program and the organization
- Assumes the role of case manager, which includes assessing client's global needs, ensuring appropriate assessment by health care professionals, coordinating the development of an Integrated Service Plan, assuring the delivery of care and the attainment of stated outcomes
- Functions within the interdisciplinary team to promote the client's optimal level of functioning through consultations with the client, family and health care professionals
- Address mental health as one of Kahnawake's top seven health priorities when program planning and providing interventions
- Has attitudes and behaviors which assure the provision of safe care and services
- Is vigilant and takes responsibility to ensure a safe environment for all
- Declares all risk situations, near misses or accidents that are witnessed or discovered on KMHC premises

- To foster an approach to care that is respectful, compassionate and culturally appropriate and competent, responsive to the needs, values, beliefs and preferences of clients and their family member, supporting mutually beneficial partnerships between clients, and health care providers
- Work in an environment that honours the wisdom of Indigenous beliefs, language, culture and traditions

DUTIES

- Evaluates clients experiencing mental health and/or behavioral challenges who have been referred by the Inpatient, Outpatient, Homecare Nursing Departments or any other Mental Health Facility
- Educates nursing staff on how to assess clients experiencing mental health and/or behavioral challenges and how to intervene effectively
- Educates nursing staff on how to support families of clients and how to promote family/caregiver participation
- Participates in the referral and follow-up of clients to Geriatric Psychiatry Outpatient Clinics (i.e. Memory Clinic at the Douglas Hospital, Jewish General Hospital, etc.)
- Provides mental health nursing care to clients facing short-term or long-term mental health issues
- Provides follow-up and outreach to clients with mental health illness, which may include; ongoing mental health evaluations, follow-up interventions and crisis intervention
- Provides support to families of clients with mental health illness through education and family interventions
- Acts as consultant and educational resource person for health care providers at KMHC and Kahnawake Shakotii'a'takehnhas Community Services
- Conducts initial assessment of clients using Mental Health Nursing Assessment Tool and reassesses client on an ongoing basis
- Develops an Integrated Service Plan in collaboration with the client, the client's interdisciplinary team, family, health care professionals and updates the plan as the client's situation changes
- Develops a Therapeutic Nursing Plan, completes Nursing Kardex and updates both as indicated
- Ensures the delivery of client and family centered care
- Participates in prevention and promotion activities focused on mental health illness to increase community awareness, education and participation
- Completes daily statistics

Additional Duties during a pandemic

- Regular phone calls to existing patients for “wellness checks”
- Meeting with patients via zoom (or other virtual platform)
- ISP Meetings and Case Conferences via Zoom (or other virtual platform)
